Terms & Conditions

Health Guarantee: Seller guarantees that this cat/kitten is healthy to the best of their knowledge at the time of sale. The cat/kitten has seen a licensed veterinarian and has received age-appropriate vaccinations and care.

Initial Health Period: During the first 72 hours after adoption, Buyer agrees to isolate the cat/kitten from other pets and **monitor for signs of illness, eating and drinking habits, litter box usage, and overall activity level.**

Veterinary Insurance Disclaimer: Seller has provided a **30-day free Trupanion insurance** trial. Buyer is solely responsible for activating the plan within 24 hours and assumes all veterinary costs incurred. Seller is not liable for any medical expenses once the cat/kitten leaves their home.

Post-Sale Liability Waiver: Seller is **not responsible for any injury, illness, or expenses** incurred after the cat/kitten leaves Seller's care.

Genetic Health Guarantee: If the cat/kitten dies within the first year due to an inherited genetic disease, Buyer must notify Seller and provide a necropsy report from a licensed veterinarian. Upon confirmation, Seller will provide a replacement cat/kitten of equal quality when available. No monetary refunds will be issued.

Refund Policy: There are absolutely no refunds under any circumstances.

Return/Rehoming Policy: If Buyer can no longer keep the cat/kitten for any reason, they **must contact Seller before rehoming**. If an appropriate home cannot be found, the cat/kitten must be returned to the Seller. If Buyer rehomes the cat/kitten without Seller's consent or violates this agreement, Seller has the right to reclaim the cat/kitten without compensation.

Restricted Rehoming Clause: Under no circumstances may this cat/kitten be sold, leased, transferred, or surrendered to a pet store, animal shelter, research lab, rescue, breeding mill, or similar entity.

Indoor-Only Requirement: Buyer agrees that this cat/kitten will **live indoors only** and will not be allowed to roam freely outdoors.

No Declawing: Buyer agrees that this cat/kitten will **never be declawed**.

No Caging or Crating: This cat/kitten will **not be confined** long-term in cages, crates, or other enclosures that restrict free movement in the home.

Personality Disclaimer: This cat/kitten has been raised in a home environment with exposure to typical household activity. Seller makes no guarantees regarding temperament or behavior but affirms that the kitten has been socialized to the best of their ability.

Legal Enforcement Clause: If the Buyer violates any part of this agreement, they will be liable for the Seller's legal fees and court costs incurred in enforcing this contract.
